**Whereas** we are very concerned about the impact of these reductions in our community <u>AND</u>

**Whereas** the Ministry of Education has established Utilization Funding to provide an opportunity for District Social Service Administration Boards to leverage supplementary funds for their community <u>so therefore</u>

**Be it Resolved that** the District of Sault Ste. Marie Social Services Administration Board maintain the current level of funding for Community Child Care."
