Audited Financial Statements

B. Bumbacco and M. Marinovich presented the Financial Statements and walked the Board members through the information provided. The DSSAB financial statements were reviewed in detail. The notes included in the financial statements were also discussed. Included is information about the Affordable Housing Program.

A tabled discussion will take place regarding the liabilities and reserves currently on the DSSMSSAB books.

Budgeting disclosures and methods differ from the financial statements and while this is not unusual it may make comparability difficult. At this time this process needs to remain as is.

The SSMHC financial statements were also discussed in detail. The recording principals are different and are not GAAP but rather follow the Social Housing Act prescribed basis. Amortization methods will need to be revised to accommodate GAAP rules. Audit notes are consistent with prior years.
