## **FINANCE**

#### Resolution #15-129

- 5.1 "Be it resolved that the District of Sault Ste. Marie Social Services Administration Board endorse the following "Interim Levies" to our contributing municipalities and appropriate Provincial Ministries that contribute the TWOMO portion as proposed by the Social Services Financial Manager:
  - 1. That the first Interim Levy equaling 25% of the Year 2015 levy be sent to the contributors with a due date of February 1, 2016.
  - 2. Since our budget is due March 31, 2016, a second Interim Levy equaling 25% of the Year 2015 levy be sent to the contributors with a due date of April 1, 2016."

5.2 "WHEREAS the District of Sault Ste. Marie Social Services Administration Board deems it necessary to borrow the sum of \$4,000,000.00 to meet, until current revenue is collected, current expenditures for the year 2016; and;

**WHEREAS** the total amount of the estimated revenues of the Board for the year 2016 not including revenue derived or derivable from the sale of assets, borrowing, Provincial subsidy, or from a surplus, including arrears of revenues and proceeds from the sale of assets is estimated to be in the excess of \$16,000,000.00;

**THEREFORE** the District of Sault Ste. Marie Social Services Administration Board pursuant to Section 9 of the District Social Services Administration Boards Act, RSO 1990, Chapter D.15 and amendments thereto, ENACTS as follows:

- 1. The Chair and the Treasurer are hereby authorized, on behalf of the District of Sault Ste. Marie Social Services Administration Board, to borrow from time to time by way of promissory note from the Royal Bank of Canada or any person, a sum or sums not exceeding \$4,000,000.00 to meet, until the revenues are collected, the current expenditures of the Board for the year, including the amounts required for the purpose mentioned in Section 9(3) of the District of Social Services Administration Boards Act and to give on behalf of the Board to the Bank or lender, a promissory note or notes, sealed with the corporate seal and duly signed for the moneys so borrowed, with interest, which may be paid in advance or otherwise, with interest at the Bank's prescribed lending rate or another persons' lending rate from time to time.
- 2. All the sums borrowed pursuant to the authority of this bylaw, as well as all other sums borrowed in this year and in previous years from the said Bank or lender for any or all purposes mentioned in the said Section 9 shall, with interest thereon, be a charge upon the whole of the revenues of the Board for the current year and for all preceding years as when such revenues are received."

## EMERGENCY MEDICAL SERVICES

M. Figliola spoke to the funding request for the 3-month bridging of the trial period for the additional ambulance in service. He noted that the next resolution for submission of a business plan to the Ministry is seeking solution to this matter.

#### Resolution #15-131

5.3 "WHEREAS on June 18<sup>th</sup>, 2015 the District of Sault Ste. Marie Social Services Administration Board approved resolution #15-058 supporting the implementation of one (1) additional ambulance staffed with two (2) part-time paramedics for a trial period of six (6) months to assess the extent of insufficient ambulance resources; AND that the required funding, of an estimated \$186,500 be drawn from the DSSMSSAB Reserve Fund;

AND WHEREAS the successful six (6) month trial period is due to expire within the next month;

THEREFORE BE IT RESOLVED THAT the District of Sault Ste. Marie Social Services Administration Board grant permission for the Sault Ste. Marie Fire Services EMS Division to continue to operate an additional ambulance staffed with two (2) part time paramedics for up to three (3) months while seeking solutions to the current insufficient ambulance resources. The required funding is estimated at a monthly cost of \$31,500 to be drawn from the DSSMSSAB reserve fund."

#### CARRIED

M. Figliola noted that this is the final piece of the puzzle in regard to up-staffing needed for EMS. A resolution from the Board supporting this issue would be helpful in the funding request from the MOHLTC. K. Lamming also asked that an endorsement from First Nations groups be included in support of the funding matter.

Concern regarding a contingency plan in the case that our proposal is not accepted was expressed. A proper financial report with options could be provided early in 2016.
