## Community Child Care Manager Request for Direction from the DSSMSSAB:

A DSSMSSAB policy with regard to funding commercial operators will be required in order to consistently address any existing or future commercial operators who request fee subsidy or wage subsidy funding.

F. Lake provided background and led the conversation regarding the funding of commercial for-profit Child Care Operators. She gave examples of what other Municipalities and DSSABs are doing in regards to a policy for this matter. This will be brought forward for further thought and discussion. At this time we have no funds available for fee & wage subsidies but a policy could be implemented should funding become available. This decision lies with the DSSMSSAB.

F. Lake offered to do more research and bring more information forward.
