### **COMMUNITY COORDINATOR**

D. Pauze discussed the Child and Family Investment Fund (CFIF) report provided. K. Streich-Poser provided background about this fund and how it evolved and eroded. The Child Benefit is now being delivered directly to households as opposed to offering the claw back funds for community programs. Alternate funding options are being examined through Ontario Works to help alleviate a portion of the lost funding.

The option of building this funding directly into the DSSAB budget was discussed. It is a priority for the Board that the funding continue and remain seamless. A resolution can be passed accordingly. A clarification regarding the funding and the DSSAB authority needs to be given. This funding is imperative to the community.

It was agreed that a report with annual costs to continue this funding will be brought forward at the next meeting. The Board would like to explore the option of continued funding in the 2012 budget. A letter to the province requesting a commitment to permanent SAR funding will be drafted.
