EMERGENCY MEDICAL SERVICES

R. Rushworth spoke about the Emergency First Response Team training for new recruits. He informed Board Members that the trainers are qualified and certified and offer a good value for the cost.

The cost centre for these expenses will be brought to the board at a future date.

ONTARIO WORKS

- P. Lebel spoke to the Ontario Works Two Year Service Plan. She provided an overview of the intentions of the plan that is employment focused. It may take some time to assist individuals that may be in a cycle situation. The Ontario Works Employment unit has moved back "in-house" to the Ontario Works offices on Albert St. and will actively work in the community with new prospective employers. The community hubs will be used to assist in creating ease for individuals searching for work.
- D. Edgar complimented P. Lebel with the way the plan was composed and the aggressive way that it tackled some of the problems associated with Ontario Works.
- P. Mick asked about the community hubs, their locations and the programs currently being run out of these assets. She was told that there are 4 community hubs and that they are undergoing renovations at this time.

Marie Housing Corporation for items which have improved and enhanced tenant accessibility and safety including:
 - One (1) automatic door opener / apartment entry door in the amount of \$3.187.38
 - One (1) automatic door opener for the laundry room door in the amount of \$2,224.82 AND
 - The conversion of a tub to an accessible step-in shower in four (4) apartments in the amount of \$4,045.40"

G. Grandinetti spoke to the 10-year Housing and Homelessness Plan. He reviewed the highlights of the plan and discussed the aging housing stock in Sault Ste. Marie.

Questions regarding the low vacancy rate and the lack of desire from contractors to build should prevalent. It was noted that the government funding for affordable housing is not available at this time. It was also noted that due to the low vacancy rate landlords have the ability to charge higher rents to tenants.

A good conversation regarding Affordable Housing in Sault Ste. Marie and the current situation was held.

D. Boulet brought Board Members up to date on the status of the relief fund. To date four (4) individuals have been helped for just over \$15,792 in expenditure. A discussion regarding the stringent eligibility requirements and the lack of people benefitting from this program were discussed. The possibility of readjusting the requirements was examined. The program mirrors the Northern Repair program and the requirements there.

It was suggested that we push this fund again with media information and releases to create more awareness. People who didn't apply the first time may need to apply now.

A snap shot of potential users of this fund – for example the number of households less that \$169,000 and households low income – could be useful information. The innovation centre may have the answers.

AND THAT the Commissioner of Social Services be responsible for facilitating these essential emergency repairs of up to \$5,000 per household. Program eligibility will be subject to the Investment in

Affordable Housing Emergency Repair policy developed by Housing Programs. Funding will be made available until the allocation has been depleted or until December 31, 2013"
