RE: Social Services Relief Funds II (SSRFII) & Mental Health and Addiction (MHA) Administration Fund Acceptance from the District of Sault Ste. Marie Social Services Administration Board (DSSMSSAB)

RECOMMENDATION

It is recommended the Sault Ste. Marie Housing Corporation (SSMHC) accept from the DSSAMSSAB accept SSRF II and MHA administration funds in the amount of \$23,479 for the purposes of investing into the construction of SSMHC Steelton Centre transitional beds.

BACKGROUND INFORMATION

The administrative funds received from DSSMSSAB will be bundled with additional Government of Canada funding provided through the Reaching Home program to support individuals experiencing homelessness awaiting for permanent housing.

SUMMARY/OVERVIEW

The additional funding will assist to meet the increased construction costs of the eight (8) transitional units in the Steelton center due to having to meet the fire separation requirements within the building code for this type of unit. .

STRATEGIC PLAN IMPACT

The awarding of SSRFII/MHA administrative funds to the SSMHC impacts the strategic plan in the area of **Service Excellence**.

FINANCIAL IMPLICATIONS

There are no net financial implications to the SSMHC.

CONCLUSION

The additional administrative dollars will increase the SSMHC current budget of \$219,425 for 2020 and assist in the construction of the transition beds.
