RE: PTC 2021-21 Elevator Modernization – 277 A Northern Avenue East

RECOMMENDATION

It is recommended the District of Sault Ste. Marie Social Services Administration Board (DSSMSSAB) enter into an Ontario Priorities Housing Initiative (OPHI) Contribution Agreement (CA) with Columbus Club Housing Corporation in the amount of \$10,735.00. for consulting services by National Elevator Consulting as per PTC 2021-21, Elevator Modernizations for Columbus Club of Sault Ste. Marie Housing Corporation.

BACKGROUND INFORMATION

National Elevator Consulting is a Toronto based full service independent elevator and escalator consulting firm with no affiliations to any elevator manufacturer, service contractor or developer, providing an unbiased expert perspective. National Elevator Consulting submitted a proposal to provide engineering and consulting services for the elevator modernization to the SSMHC in May 2021.

The OPHI program is designed under the bilateral agreement between the province of Ontario and the federal government to address local housing priorities, including affordability, repair and new construction. It is modelled after similar, previous affordable housing programs, with the most recent being the Investment in Affordable Housing Program Extension (IAH-E). There are a number of additional features in this program, including the addition of a support services component and the eligibility of social housing under Ontario Renovates.

SUMMARY/OVERVIEW

The scope of the work includes, full contract administration, pre-construction site inspections, preparation of specifications and bid documents, and a detailed scope of on going maintenance requirements, analysis of bids and post construction inspections.
