RECOMMENDATION

In accordance with the Sault Ste. Marie Housing Corporation (SSMHC) purchasing policy, the tender award committee recommends that the Sault Ste. Marie Housing Corporation award the elevator consulting services for PTC 2021-21 Elevator Modernization 588 Albert Street West to National Elevator Consulting for a total contract price of \$7,352.16.

BACKGROUND INFORMATION

National Elevator Consulting is a Toronto based full service independent elevator and escalator consulting firm with no affiliations to any elevator manufacturer, service contractor or developer, providing an unbiased expert perspective. National Elevator Consulting submitted a proposal to provide engineering and consulting services for the elevator modernization in May 2021.

SUMMARY/OVERVIEW

The scope of the work includes, full contract administration, pre-construction site inspections, preparation of specifications and bid documents, and a detailed scope of on going maintenance requirements, analysis of bids and post construction inspections.

STRATEGIC PLAN IMPACT

The elevator replacement at 588 Albert Street West impacts the strategic area of Service Excellence.

FINANCIAL IMPLICATIONS

There are no financial implications to the capital budget. The contract price is within the original budgeted amount for this capital project.
