All the sums borrowed pursuant to the authority of this bylaw, as well as all other sums borrowed in this year and in previous years from the said Bank or lender for any or all purposes mentioned in the said Section 9 shall, with interest" thereon, be a charge upon the whole of the revenues of the Board for the current year and for all preceding years as when such revenues are received."

RE: Homelessness Prevention Program Funding Slippage 2023/2024

RECOMMENDATION

It is recommended the District of Sault Ste. Marie Social Services Administration Board (DSSMSSAB) re-allocate 2023/24 Homelessness Prevention Program (HPP) funding to a supportive housing program at 101 Chapple Street and to support the development of programming at the Community resource Centre as follows:

- 1. \$718,718 for supportive housing
- 2. \$28,546.33 to move existing residents at 101 Chapple into new housing units
- 3. \$27,254 for a three month contract to initiate and coordinate programming at the CRC

BACKGROUND INFORMATION

In July of 2023, the DSSMSSAB approved the investment plan for the Homelessness Prevention Program funding for fiscal 2023/2024. As a result of our need to consult with, and secure community partners, many of the service contracts with community partners were pro-rated, which resulted in underutilization of funds for fiscal 2023/2024 only. To date date totals \$ 544,518.33. In addition, there is also unspent funds that were dedicated for the Youth Portable Housing Benefit – a result of youth experiencing difficulty securing accommodations in a timely manner, and finally, an average of \$20,000 is being spent monthly as part of the Housing Stability Bank, resulting in a surplus of funds in the Housing Stability Bank as well due to later implementation and underutilization. The chart below outlines the surplus funds to date.

As part of the initial HPP investment plan, a one- time capital investment of \$100,000 was approved by the DSSMSSAB for renovations to 101 Chapple Street to convert the common room into a communal kitchen area/ programming space as well as converting a janitor room into office space. This renovation has since been completed (November 2023) and is now ready to accommodate a service provider to operate a supportive housing program for 10 high acuity women. This will increase the total number of supportive housing program spaces dedicated to women to 18 (8 located at Pauline's Place and 10 proposed for 101 Chapple).

It is our intention to move the semi-supportive housing program currently operating at 137 East Street to 101 Chapple Street and expand service to offer 24-7 supports. This will offer better services and security to vulnerable women in our community. The layout of the 137 East Street does not allow for secure entrances or monitoring who is accessing the site or each unit, despite having camera systems in place. The move to a secure one entry location like 101 Chapple Street will mitigate and protect those most vulnerable. We will repurpose 137 East Street units and offer them to community members who do not require intensive supports to remain housed.

Additionally, the Community Resource Centre (CRC) officially opened in September of this year. Social Services staff and community partners are worked very hard to serve community partners within the space. The needs of people accessing the services are often very acute and the CRC team (agencies) have determined that a short one-time investment for a CRC Coordinator would greatly assist in coordinating activities, developing activity/programming schedule, etc. to ensure that guests of the CRC are participating in active programming on a daily/regular basis.

SUMMARY/OVERVIEW

The John Howard Society (JHS) of Sault Ste. Marie has indicated an interest in delivering the supportive housing program for 101 Chapple. The John Howard Society has been part of our Homeless Prevention Team (HPT) for many years, is currently providing housing supports at 137 East Street and has the capacity to excel in this scope of work. Social Services is recommending that we award JHS with a multi-year contract to offer supports at 101 Chapple.

Additionally, Social Services has identified a very capable team member to lead the animation of programming at the CRC for a three month period; who will be tasked with implementing programming and building partner agency capacity.

STRATEGIC PLAN IMPACT

The Homelessness Prevention Program aligns with the pillar of Service Delivery and Community Partnerships.

FINANCIAL IMPLICATIONS

There are no net municipal financial implications since the Homelessness Prevention Program funding is 100% provincial funding.

101 Chapple – JHS and has submitted a budget in the amount of \$1,315,972 over three years to operate 24/7.

The following chart outlines the budget details:

Budget Line	Budget Allocations (2024-2026)

The recommendation is to use remaining \$774,518.33 HPP as follows:

- 4. \$718,718 for supportive housing
- 5. \$28,546.33 to move existing residents at 101 Chapple into new housing units
- 6. \$27,254 for a three month contract to initiate and coordinate programming at the CRC

There will be an overall funding shortfall of \$27,254 that will need to be funded over the life of the agreement in 2026 to operate 101 Chapple.

CONCLUSION

Increasing supportive housing options in our community is essential in order to continue to support those most vulnerable. We are pleased that we have an opportunity to fill a much needed gap in our community. Additionally, community members accessing the CRC require more structure and programming than is currently being offered to assists in their life stabilization.
